- 1.3 The tenderer should furnish EMD OF Rs.5, 000/-(refundable) in the form of BD.

7. EARNEST MONEY DEPOSIT:

7.1 The tender should be accompanied with Earnest Money Deposit (EMD) amounting Rs.5000/-(Five thousand) in shape of Demand Draft from any Nationalized/ Scheduled Bank in favor of Superintendent, SVPPGIP, Cuttack.

9. PRICE EVALUATION:
